3. REPORTS

- **Chair Report:** There was no formal report this evening, other than to extend appreciation to all involved for their time and effort in reviewing the budget.
 - **Policy:** The committee continues to review existing policies and consider new policy development. There are no policy items to report this evening.
 - **Personnel:** None.
 - **Athletics:** The girls' basketball team has recorded three wins so far this season, marking a strong improvement from last year when the team did not secure any wins. This represents a very positive start to the season. Both the boys' and girls' basketball teams are scheduled to play at Eli Whitney Technical High School tomorrow. Additionally, Middle School Basketball Night is scheduled for February 4th, when both the middle school boys' and girls' teams will compete at East Haven High School.
 - **Arts:** None.
- **Correspondence:** The Board received several email correspondences from Momauguin PTO members, families, and staff expressing their request for funding to support a new playground at Momauguin School. As the submissions did not include mailing addresses, individual names were not read. The correspondences also included photographs of playgrounds at each school. It was noted that the current Momauguin School playground was purchased approximately seven years ago.
- **Assistant's Report:** The Assistant Superintendent reported on the College and Career Readiness presentation attended by approximately 30–35 families, including eighth-grade families, which was designed to support informed decision-making about high school enrollment and course selection. The presentation emphasized that rigorous coursework looks different for each student and should reflect an appropriate level of challenge aligned with individual goals.

Families were informed about opportunities to earn college credit through academic courses, CTE programs, fine arts, and other pathways, highlighting benefits such as increased college readiness, confidence, financial savings, and development of skills aligned with the Vision of the Graduate. Updated handouts outlined current college credit offerings and CTE pathways, as well as additional career exploration courses including engineering, drone technology, aviation, and the teacher assistant program.

Naviance Student and Naviance Family were introduced as tools to support career exploration, self-discovery, and academic planning. Students use Naviance to complete interest surveys, explore career pathways, document progress toward the Vision of the Graduate, and build digital portfolios. A key feature noted was the ability to generate an instant resume using students' accomplishments, activities, and transferable skills. Families were encouraged to access the platform following a recent ParentSquare communication.

- **Superintendent's Report:** Last week, we hosted a College and Career Readiness event, which showcased our district's innovative approach to student pathways. Families, student leaders, teachers, and administrators engaged in discussions about designing rigorous, flexible coursework that supports both college and career readiness. Representatives from UConn and Connecticut State attended, and a student panel shared insights on AP courses and skill development.

We also held our first TEAM Symposium, bringing together six early-career staff members to share learning in a collaborative, reflective format. The symposium format is a new opportunity developed by TEAM Facilitators Jen Bauer and Joseph Marangell, in coordination with Lisa Veleas. It provides an alternative to the traditional essay format used to clear credentials in the first years of teaching. Participants' reflections surfaced their learning in relation to the role of teachers as facilitators of learning, bolstering student agency without compromising rigor, and supporting conditions for student-initiated revision. Staff left energized, seeing the process as authentic professional growth rather than a compliance task and feeling as though it built community within and across schools. Our next symposium is scheduled for May. Additionally, staff interest in our Science of Reading modules exceeded expectations, demonstrating a strong commitment to deepening instructional knowledge.

Finally, I want to acknowledge the extraordinary collaboration between our custodial and maintenance teams and Public Works in ensuring schools opened safely on a two-hour delay during last week's storm.

- **COFO Report:** In response to a question from the board regarding the expenditure to Synology, the funds were used to support an ongoing technology project to enhance the district's infrastructure and expand system capacity. Similar upgrades are planned for all of our elementary schools and the high school, over a period of time.
