Discuss & Take Any Necessary Action on the Hagaman Library

Chairman Savo passed out the information he received from the Library Director with regard to the elevator and ADA Compliance in the Community Room. Chairman Savo thinks that the Director should go to the Library Trustees with regard to the elevator. There was a discussion as to what funds are available for these projects. He will talk to Art DeSorbo regarding the letter from the Director. Commissioner Hoff thought that the elevator should take precedence over the Community Room. Chairman Savo explained to Commissioner Hoff that there may be Capital Improvement funds that they need to look into first. He will check with Mr. DeSorbo regarding that as well. Commissioner Martens made a **MOTION** for move forward and explore fund options to the Hagaman Memorial Library ADA compliance. Commissioner Tufano seconded. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

Discuss & Take Any Necessary Action on the Senior Center

Chairman Savo explained that the grippy tape was sprayed on the ramps to reduce the chance of falling or slipping on the ramp.

Discuss & Take Any Necessary Action on Handicapped Parking Spaces at Four Beaches Condos and Momauguin Baseball Fields

A discussion was held with regard to the handicapped spaces at Four Beaches Condo. A letter was sent from Art DeSorbo asking the commission to look into this. There didn't seem to be enough spaces there. A discussion was held and it was determined that it might be the Association's responsibility. It will be looked into and reported at the next meeting.

With regard to the spaces for Momauguin Baseball Fields, both Chairman Savo and Vice-Chairman Stevens said the bathrooms are definitely not ADA complaint. It probably only needs a simple ramp. Chairman Savo will contact the group and discuss the parking situation with the Police Department to see if they could make some spaces on the street Handicapped Only. **MOTION** made by Commissioner Tufano and seconded by Vice-Chairman Stevens to have Chairman Savo approach the Police Commission regarding these signs. All were in favor, none were opposed and none abstained. **MOTION CARRIED**
