Richard DePalma states that he went on the government website for security grants. He states our share would be \$159,000 for school security. Paul Rizza states if we look into 13/14 capital we did fund \$130,000, \$30,000 for doors and \$100,000 for various securities. Our match is \$159,000, so if you take this \$30,000 and \$130,000 we are at the 160 mark. Richard DePalma asks if we are changing locks at the high school due to the fact that many past employees have a key? Paul Rizza states yes. Sal Maltese states on that pavement and concrete repairs didn't that we have that before? Paul Rizza states yes 2 years ago – currently we in a process up at the High School to put brand new concrete down, so far 1/3 is complete. The total job will be in the neighborhood of \$80,000 and the balance will come from previous bonds and additional schools will have repairs as well. Front and back doors will have upgrades as well and security cameras at some schools. Noreen Clough asks what is this environmental study? Paul Rizza states this is

something that Dr. Porche Bonner has formed a committee to look into closing, expansion or merging school buildings it's really just a study to see what schools we could maybe close. Richard DePalma asks about paving is this town or school? Paul Rizza states schools. Richard DePalma asks are we paving the town roads? Paul Rizza states yes but that will be coming from L.O.C.I.P money and town aide and we will have an additional plan for sidewalks. Richard DePalma states he called the state representative and the town has to develop a plan before we can apply for this grant. If someone got the ball rolling there is money air marked out there for this block grant. Attorney Zullo states that this is already in the process of being looked at. Paul Rizza states that you have to have the engineering work done prior to asking for the money. Noreen Clough asks about Town Fair Tire and its expansion. Attorney Zullo states that the money is for engineering work to relocate the road so Town Fair can expand the building for overflow inventory. Noreen Clough asks about the beach line item. Paul Rizza states this money if for a wall to be built at the beach. Noreen Clough asks about the engineering survey for North High Street. Paul Rizza states that we have the opportunity to put in sidewalks as well as bike paths and we also have to look at possible purchase property or part thereof and there is another part of the plan to branch that up towards Rt. 80 and the state is putting up quite a bit of money as well.
