PUBLIC WORKS MECHANIC

Mr. Coppola, the Assistant Director of Administration and Management was in attendance to discuss this position. He is concerned that there has not been any interest in the position to date and would like to know what can be done if no one applies for the job. It is crucial that the position is filled before winter so the trucks can be outfitted for plowing. The Chief Examiner advised him that she had received 2 applications. The posting will expire on September 18th so there is time for a few more applications to be submitted. Mr. Coppola also stated he did know if the lack of interest stemmed from the rate of pay, which is lower than average for mechanics in the area but it is something he will look into if he is unable to find a suitable candidate for the position.

POLICE DEPARTMENT POLICE OFFICER C-NEW RECRUIT EXAM

106 applications were received. The exam was held on July 10, 2018. 85 candidates took the written exam and 48 passed. The Oral Interview for this position was held on August 1 and 2. 45 candidates participated and

35 passed. The final date for the C.H.I.P. Test was August 18, 2018, 4 candidates failed to complete that part of the exam and we have a final list consisting of 31 names. The Police Commission has not indicated that they are ready to hire from this list at this time.
