## **POLICE DEPARTMENT**

#### CONSENT DECREE

Police Chief Larrabee and Attorney Sgrignari addressed the Commission regarding the responsibilities of testing and recruiting as stated in the Consent Decree between the Town and The Department of Justice.

Attorney Sgrignari stated that paragraph #183 of the Decree gives the Police Department 90 Days to make recommendations regarding recruitment and testing. The Civil Service Commission will be responsible for accepting and implementing this plan during the recruitment of new officers. Some of the suggestions which have been made include offering extra points to candidates with college degrees and to those candidates who are proficient in a foreign language. These new recommendations will need to be included in the Notice of Testing and advertisements. Attorney Sgrignari felt the best way to achieve this would be to amend Rule 7, Section 2 of the Civil Service Rules and Regulations.

The Police Chief introduced Lt. Lennon who is the Subject Matter Expert for the Town and is working on compliance with the Justice Department. The Chief addressed other requirements he would like added to the advertisement as a condition of employment such as a ban on certain tattoos, no tobacco use and a repayment clause for leaving within a certain period of time after hire. The Chief also discussed changing the weighting of testing components and stated it was his opinion that an Oral Exam is a more effective way of finding the best suited candidate for leadership positions and that he will be requesting this be changed for future promotional exams.

Attorney Sgrignari agreed to prepare a proposal for the Commission to review before the March 11, 2013 Regular Meeting and would email it to the Chief Examiner for dissemination to the Commission members.

#### POLICE OFFICER C

The Board of Police Commissioners has requested a certified List to fill 4 positions from the Eligibility List for Police Officer C.

A MOTION was made by Mr. Stacey to Certify the top 6 available names in rank order to fill 4 positions from the Eligibility List for Police Officer C. Mr. Carocci Seconded.
