The Town of East Haven, CT Civil Service Commission Minutes December 9, 2013, 7:00 pm, 250 Main Street

The Regular Meeting of the Civil Service Commission was held on Monday, December 9, 2013 in the Mario Giamio Conference Room, Town Hall, 250 Main Street, East Haven, CT.

The meeting was called to order at 7:00 p.m.

Mr. Gentilesco addressed the Commission. He requested that the Civil Service Commission prepare an application and Notice of Testing for the new position of "Public Safety Dispatcher". He advised the Commission that the Mayor had created an Ad Hoc Committee consisting of himself, the Police and Fire Chiefs, Town Engineer Kevin White, Attorney Frank Kolb and Paul Rizza to review the option of creating a combined Dispatch Center at the Police Department. The target date for this is July 1, 2014. This would allow the Town to have 2 Dispatchers on duty at all times and will free up a Police Officer to go on the road on each of the three daily shifts at the Police Department. The estimate is there will need to be 6 Dispatchers hired. The Chief Examiner stated she would need a job description to post the Notice of Testing. Mr. Gentilesco stated they would be meeting with the Dispatchers Union this week and should have a job description by the end of the week. The Fire Chief and Police Chief both expressed their support of this plan. The Commission questioned the Police Chief regarding the current use of Police Officers to dispatch. The Police Chief stated there are 21 shifts per week manned by Police

Officers. Not all of them are overtime. Both Chiefs expressed a need for someone who is bilingual in Spanish.

A MOTION was made by Mr. Carocci to begin the testing process for the position of Public Safety Dispatcher with a written exam with a pass point of 60 to be worth 100% of the final grade.
