NEW BUSINESS

POLICE DEPARTMENT

LIEUTENANT

A letter was received requesting a new exam be held for the position of Lieutenant. Deputy Chief Lennon was in attendance to discuss the matter. He stated he has done some research into the weighting of the written and oral exams typically used at this rank. He requested the

Commission review its standard procedure and consider using a system that would give more weight to the oral than the written exam. Mr. Stacey requested that the Chief and Deputy submit this research to the Commission for its review before this matter is voted on.

SERGEANT

A request was made to fill two positions from the eligibility list for Sergeant.

A MOTION was made by Mr. Stacey to certify the top four available names in rank order from the eligibility list for Sergeant to fill two positions.

A MOTION was made by Mr. Stacey to establish a rolling recruitment for "Police Officer C-P.O.S.T. Certified Lateral Transfer" using PoliceApp.com and to require an application fee of \$41.00, candidates pass the C.H.I.P. test at 40% and a written exam with a passing score of 60% worth 100% of the final score in addition to being P.O.S.T. Certified Police Officers in the State of Connecticut and passing any other requirements set forth by P.O.S.T.
