A new test is needed to fill some of those vacancies and enroll the candidates in the Fall Fire Academy class. He presented the Commission with a list of requirements which would be addressed at the time testing commences either in the Notice of Testing or

with an amendment to the rules. These request will be forwarded to Attorney Zullo for his advice and the matter will be dealt with at the March meeting.
