For admissions we had 0 for DMHAS(these were clients already enrolled in clinic and converted to DMHAS) and 3 discharges (from DMHAS only - not from caseload) and 7 for Non-DMHAS admissions and 2 discharges.

The current active caseload as of February was 201
This includes Non-DMHAS of 125 and DMHAS 76. We accumulated 2.75 hour of in-kind services for the Dept. of Education.

Beth Trotta reports that they have hired a LCSW Emma Miller that has started her employment. Her case load is filling up and she can see children but she's mostly hired for the Medicare case load. We are now fully staffed. On Monday April 2nd I will meet with the Town Council for the rest of the process for the budget.
