The East Haven Counseling & Community Services held a Meeting on Tuesday, February 27, 2018 at 7:00 P.M - 595 Thompson Avenue, East Haven, CT 06512.

**1. Roll Call**

Chairman Matt Abbott, Arlene Hackbarth, and Nicole Serio-Merritt were present. Also in attendance was Ms. Beth Trotta, LCSW, BH Care Director. Sandra Enders and Samantha Batson were absent.

**3. Ms. Beth Trotta, Program Manager to update commission on current clinic situation.**

Data for the month of January 2018. Ms. Beth Trotta stated that they had 24 calls requesting service. Of that, 2 were referred out or not eligible/not appropriate or no response 4 did not show for orientation/intake. For admissions we had 2 for DMHAS( these were clients already enrolled in clinic and converted to DMHAS) and 0 discharges (from DMHAS only - not from caseload) and 7 for Non-DMHAS admissions and 7 discharges.

The current active caseload as of January was 202.

This includes Non-DMHAS of 123 and DMHAS 79. We accumulated 1.5 hour of in-kind services for the Dept. of Education.

Beth Trotta reports that they have hired a LCSW Emma Miller that will start next week. She has experience working in ICAPS program in the home. Beth states that there was a change in the budget this year. Bob Petrucelli from the Teen Center/Community Services program will not be in our budget this year. The budget is coming in at around \$40,000 less than last year. Beth will meet with the BOE and then the Town Council after that. Very few changes were made to the budget this fiscal year. We were approved for new flooring. Painting has been requested as well as new carpeting in the offices along with tile or some other type of flooring in the high traffic areas. New chairs for the waiting room are in need and we will be getting ; per the Department of Public Health.
