Re: East Haven Town Hall – Starting **MONDAY- JANUARY 3<sup>rd</sup>** Town Hall will have Limited Access <u>UNTIL FURTHER NOTICE</u> due to COVID 19- Essential Services will remain available as outlined herein.

Due to increase in cases of COVID 19 cases in our town and throughout the region, the East Haven Town Hall will be closed to the public <u>UNTIL FURTHER NOTICE</u>, with limited exceptions for essential services <u>by appointment only</u>.

The administration, along with East Shore Health District, continues to monitor and evaluate the situation in our community, and the surrounding area. Additional information regarding the status of Town Hall will be provided ON A WEEKLY BASIS.

All other in person services are suspended at this time which includes Notary Public and marriage license applications. If you have questions about these services, please contact the Town Clerk's office.

Rules regarding the transfer of paperwork for all circumstances and services will be monitored and directed by the Town Clerk, and should be strictly adhered to for everyone's safety.
