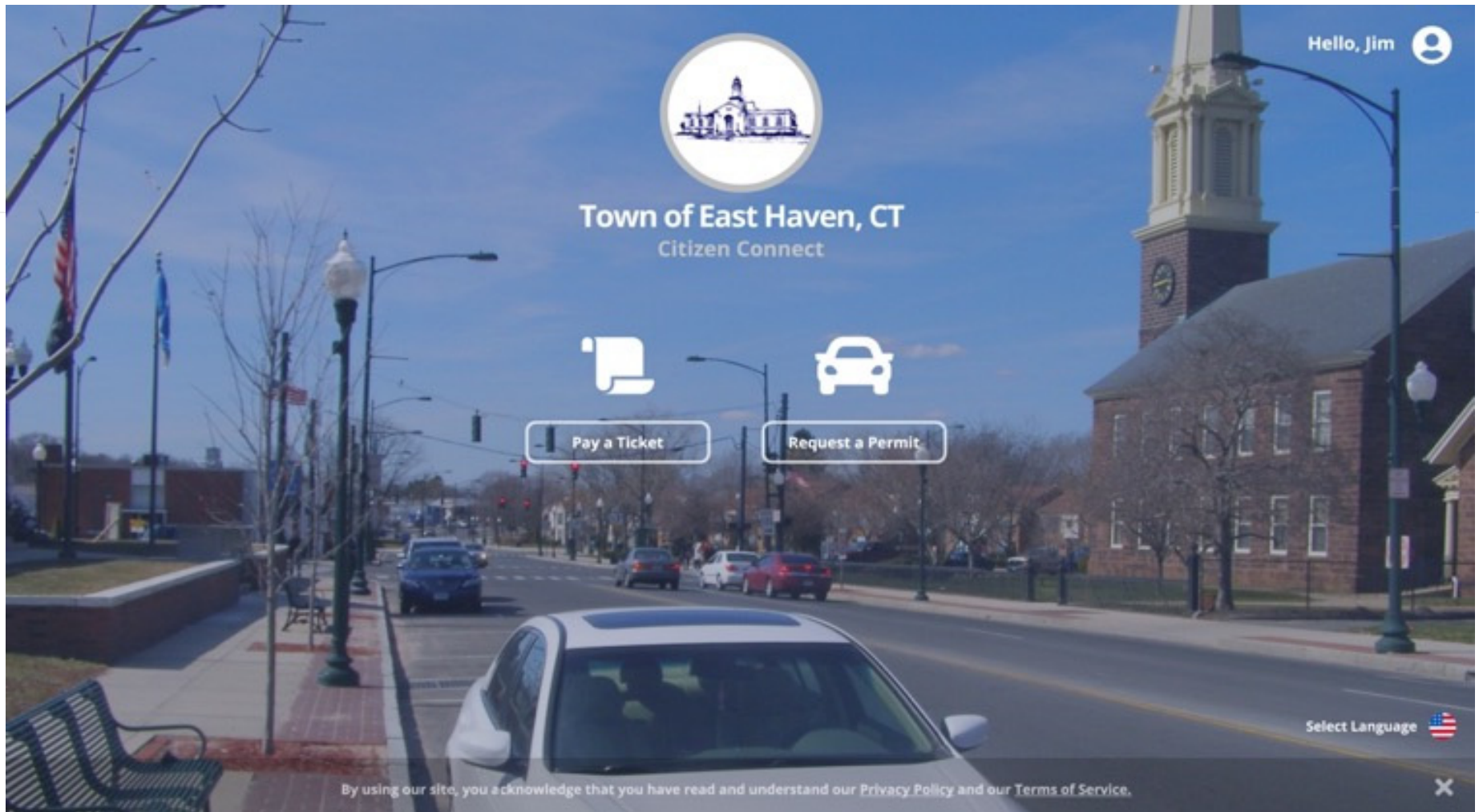


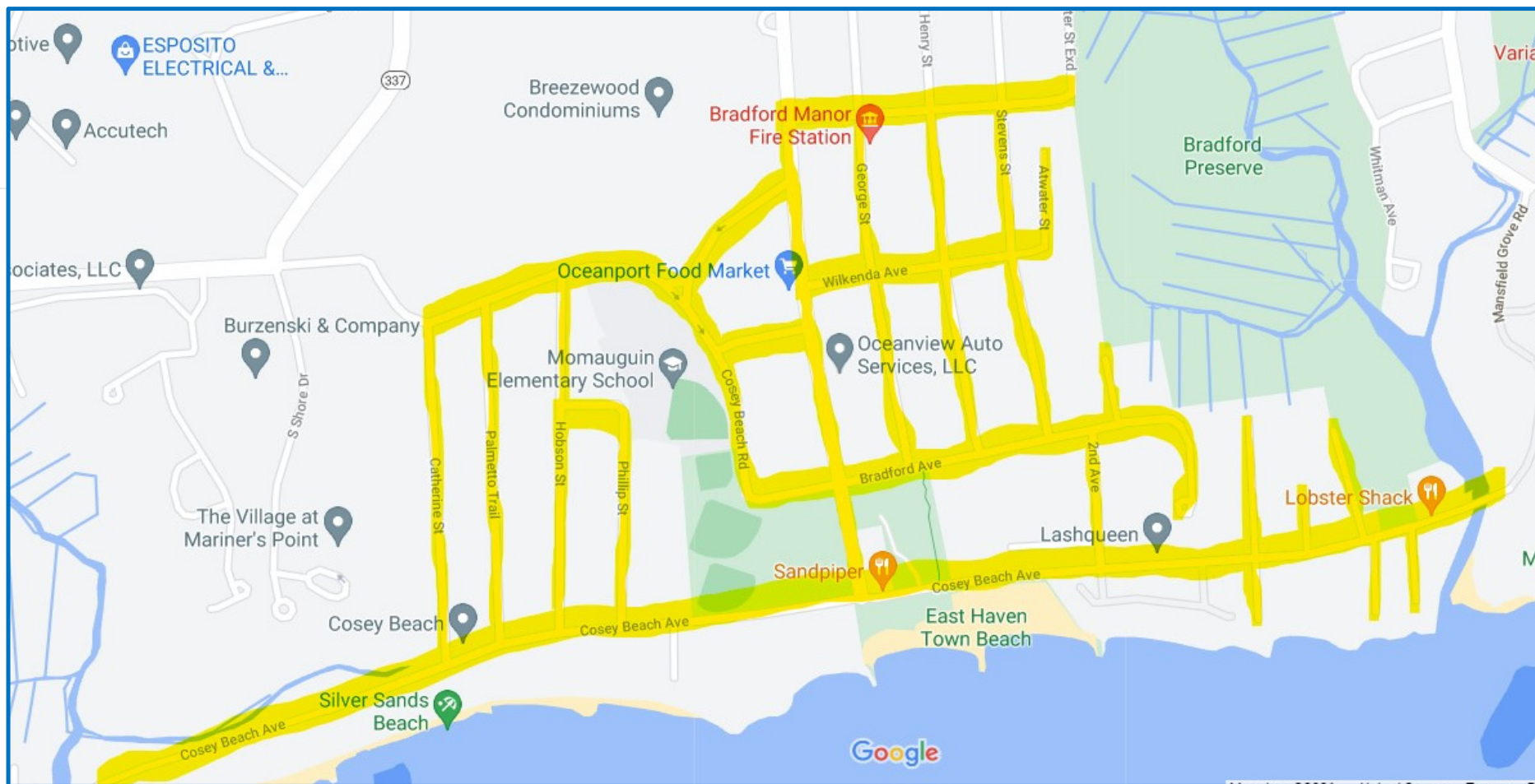


Goals of the Plan

- Henry Street (south of Soundview Avenue)
- Stevens Street (south of Soundview Avenue)

- Cold Spring Street
- Cosey Beach Road (from Coe Avenue to Catherine Street)
- Phillip Street
- Hobson Avenue

*There will be 10-minute pick-up/drop-off spots monitored by the Town Beach employees. The vehicle operator must remain with the vehicle.





Who is a Resident?

For the purpose of the Town Ordinance, a resident is:

- Someone who owns residential real property in Town – with proof of residency or ownership (i.e., utility bill, mortgage bill, valid driver's license, property deed)
- Someone who has legal tenancy (i.e., rental or lease agreement)





Town Residents

- Town residents can obtain an annual electronic permit to park in restricted parking areas via the Town or Police Department websites
- Town residents will not incur fees to register
- Those residents who do not have access to register electronically will be able to register in-person at Town Hall or the Police Department
- Restricted parking areas will be marked by signage or pavement markings
- Permit parking will be enforced from May 15 through October 15, 7:00 AM to 9:00 PM





“What do I do when I have out-of-town visitors?”

- Residents who live on the affected streets will be able to obtain visitor passes electronically from the website or in-person at the Mayor's office
- Visitor permits are temporary and time-limited to be used for short periods of time
- Visitor permits do not guarantee a parking space





Parking Lots

- Parking is also available to all Town residents free of charge at both the main and splash pad parking lots
- The main parking lot will have parking available to non-residents for a daily fee
- Both parking lots will be monitored by the Recreation Department's parking attendants
- The requirements for access to the parking lots will be the same as resident street parking
- As a reminder, overnight parking in the lots is prohibited from May 15 through October 15

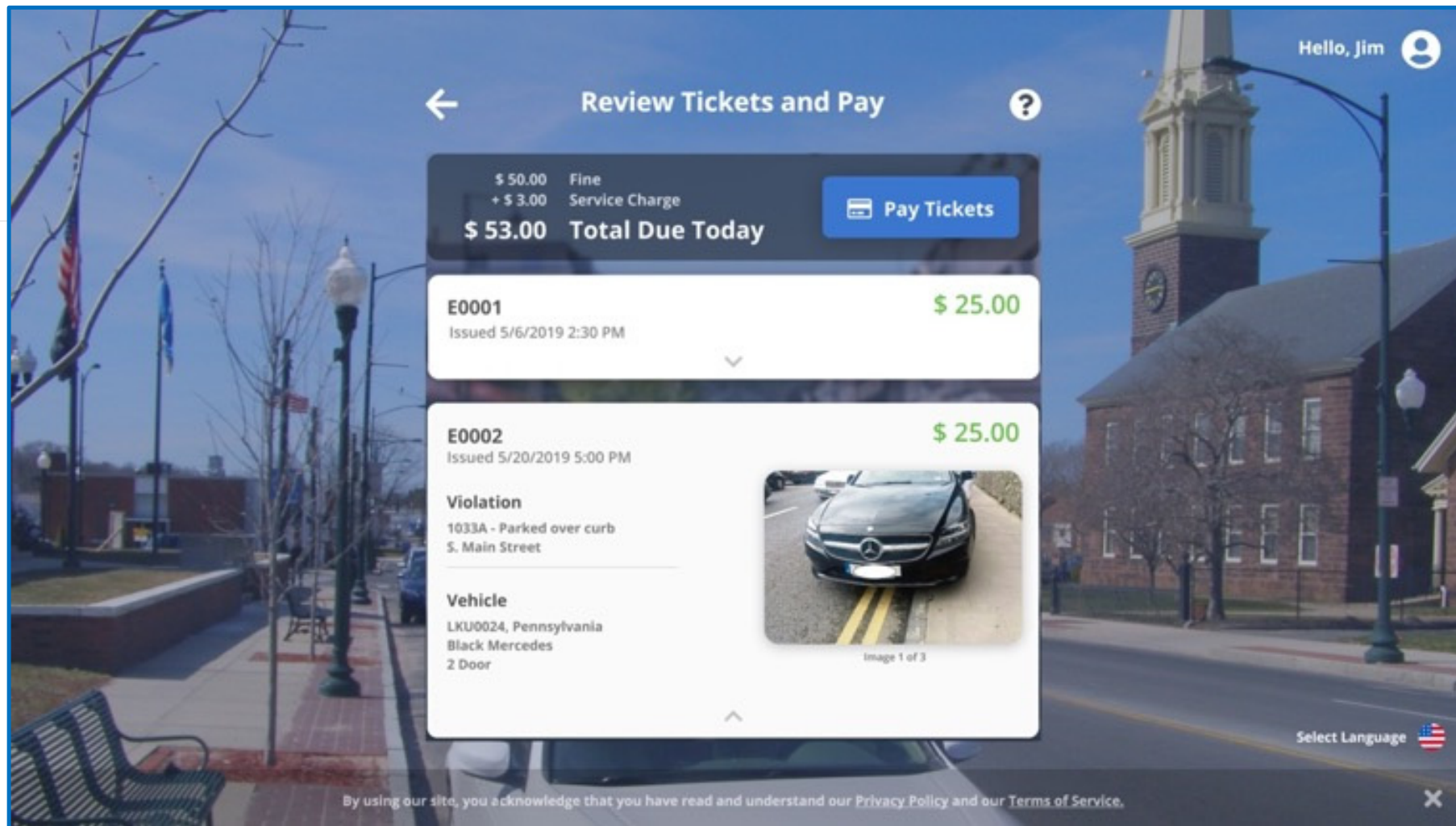
