Director Pane stated that monitored parking is available in the lot behind the Sandpiper and across the street from the Sandpiper on weekdays from 10:30-2:30 and 9:00-3:00 on the weekends. Chairwoman Adamczyk stated she would stay on top of the situation and get back to Mrs. Stacey with any new information.

**Directors Report**

Director Lou Pane stated that everything is going well with the ice rink. It is currently used from 2:00-11:00 daily and they have been working on collecting the rental fees from the organizations that use the rink. Some work has been done on the pool, with broken benches being fixed. Public Works has been trying to take care of things there. Aerobic swim is doing well with 25-30 people in attendance and open swim at night has around 8-12 people. They always get less people in the winter and as soon as spring comes the numbers will pick up. The Rec. Dept. had 350 calls for the Santa Hotline this year, so lots of families utilized that program. Numbers are up in the free children's basketball clinics which are held at Tuttle. Last year there were 32 kids and this year there are 65. The Men's basketball league is up and running as well at the Middle School 2 nights a week. He has put his budget request together and has already submitted that to the Finance Department. Lou explained the vouchers for senior citizens to use the facilities.

**Old Business**

Vice-Chair Anastasio stated that he had a meeting with Sal Brancati from the Mayor's Office with regard to funding problems with the pool. He is also not involved in that other committee for Tyler Street. He thanked Lou Pane for assisting with a problem with an employee and fixed the situation. He also appreciated all the help getting things stabilized at the pool and said there are no major issues at this time.

**New Business**

There will be no meeting held in February due to members not being able to attend. The schedule of dates was discussed and a **MOTION** was made by Commissioner Porto to accept the dates for 2015 meetings as read. Chairwoman Adamczyk seconded. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

There being no other business to come before the commission, a **MOTION** to adjourn the meeting at 7:50 was made by Chairwoman Adamczyk and seconded by Commissioner Porto. All were in favor, none were opposed and none abstained.
