**Approval of Minutes**

**MOTION** to approve the minutes of the April 8, 2013 meeting made by Vice-Chair Adamczyk and Chairman Santomassimo seconded. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

**Correspondence Received**

A letter from Tuttle School PTO requesting the use of the Town Green on 5/19, 6/1 or 6/2 for a Fundraiser Tag Sale. After much discussion and because of the short notice and the legal and financial aspects, Chairman Santomassimo made a **MOTION** to deny the request. Commissioner Anastasio seconded. The PTO must come before the commission in the future if the interest is still there to hold the fundraiser. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

The CT Stingers requested use of the pool for June 2<sup>nd</sup> for a fundraiser for their Cooperstown trip. After discussion it was determined that the pool charge would be waived if the pool was available but the organization would be responsible for 4 lifeguards for a minimum of 4 hours. The cost would run around \$160 for that. Vice-Chair Adamczyk made the **MOTION** that if the Stingers paid for the lifeguards the use of the pool would be waived. Chairman Santomassimo seconded. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

A letter from Angela Svendsen requesting use of the Town Green for a wedding to be held on June 29<sup>th</sup> at 4pm was received. After discussion, a **MOTION** was made by Commissioner Anastasio to allow use of the Town Green for the wedding. Pending date approval along with the stipulations of

**Director's Report**

Director Pane handed out his report which is attached. Discussion was held with regard to the charging of fees to East Haven Aquatics. After much discussion, Vice-Chair Adamczyk made a **MOTION** to waive the \$50 per hour fee for use of the pool for EH Aquatics. Chairman Santomassimo seconded. All were in favor, none were opposed and Commissioner Anastasio abstained. **MOTION CARRIED**

**Old Business**

Discussion was held with regard to the East Haven Umpire Association. They receive free use of the lights and maintenance of the fields. They are a private association unlike the other leagues in Town which are Town run leagues. A suggestion was made that they pay 1/3 back to the Rec. Dept. to go towards improvements of the fields if they aren't paying for use or maintenance. The commission would like them to also come to the commission in August to request the use of the fields they would like. The pool gives back 6% of what they bring in for improvements to the pool for usage. No action was taken on this discussion although Chairman Santomassimo would like to have the President, Al Carfora or Vice-President, Ed Muzyka of the league be in attendance at the June meeting.
