1. Call to order and Introductions.

Chairwoman Cofrancesco called the meeting to order at 10:06 a.m. All present introduced themselves.

2. Presentation: 2024 Regional Comprehensive Economic Development Strategy (CEDS) Update

Barbara Malmberg gave a presentation on the Comprehensive Economic Development Strategy (CEDS) 2024 Update. Malmberg reviewed demographics, economic growth, and key sectors: healthcare, higher education, bioscience, manufacturing, arts, culture and tourism, and entrepreneurship. She also reported on QuantumCT, ClimateHaven, and regional progress: Regional Sector Partnerships, SCRCOG Housing

Committee, high-speed broadband, Transportation, Arvinas & Alexion expansion, and Sustainable CT certification, as well as the challenges faced by the region in 2024: financial, population & workforce, diversity, sustainability, and aging infrastructure.

3. Adopt Minutes of March 27, 2024 SCRCOG Meeting (motion))

Chair Cofrancesco referred to the minutes of the SCRCOG Meeting March 27, 2024, which were included in the agenda packet. Motion made by Mayor Garrett and seconded by First Selectman Freda. Motion passed unanimously.

4. Treasurer's Report for month ending March 31, 2024 (acceptance)

Mayor Borer reported that as of March 31, 2024, SCRCOG had \$2.65 million in total assets of which \$1.4 million was in cash and investments. There was \$197,000 due from the CT DOT and \$57,000 was due from DEMHS. All expenses appeared to be appropriate for the one-month period. Mayor Garrett made a motion to accept and First Selectman Hoey seconded the motion which passed unanimously.

5. MPO Business

a. 2021-2024 Transportation Improvement Program Amendment Thirty-Five (motion)

First Selectman Cosgrove, Chairman of the Transportation Committee reviewed the amendment, which had been approved by the Transportation Committee, and made a motion to approve. First Selectman Hoey seconded. The motion passed unanimously.

b. 2025-2028 Transportation Improvement Program

First Selectman Cosgrove reported that the Transportation Committee considered and approved three resolutions: (1) the Ozone Air Quality Conformity Resolution, (2) the PM 2.5 Air Quality Conformity Resolution, and (3) the 2025-2028 TIP Resolution. Cosgrove reported that all three resolutions were approved unanimously by the committee. For the Ozone Air Quality Conformity Resolution, a motion was made by Mayor Garrett and seconded by First Selectman Hoey. Regarding the PM 2.5 Air Quality Conformity Resolution, a motion was made by Mayor Garrett and seconded by First Selectman Hoey. Regarding the 2025-2028 TIP Resolution, a motion was made by Mayor Garrett and seconded by First Selectman Freda.

c. <u>Deputy Director/Director of Transportation Report</u>

Deputy Director Francis advised that the kick-off for the Regional Bike/Ped Plan begins this week. Francis also noted that the data collection phase continues for the UPWP studies and reminded all CEOs that they may be asked for information or to serve on the Technical Advisory Committee for the Study. Francis reported SCRCOG had the first meeting for the on-boarding process Francis also mentioned that there are still vacancies for the SCRCOG staff positions of Highway Safety Specialist, Transportation Planner, and Project Manager.

d. Transportation Staff Report

James Rode, Principal Transportation Planner, reported LOTCIP received two new applications, one submitted by the Town of Woodbridge, a result of a transportation study. The Town of Guilford received their Commitment to Fund letter. New Haven has submitted final design plans for their project. Rode also reported they received 14 applications for the Section 5310 Grant Program which provides funding for senior center buses. Tatum Thomas, GIS/Data Manager, reported that if a municipality uses something other than New England GO to gather personnel data, they should provide SCRCOG with the data and source.

e. Greater New Haven Transit District Report

Mario Marrero reported that Municipal Grant applications are due by May 15th. The new Regional Rides Program has a reduced cost per trip which will allow for additional trips 24x7 which now includes Sundays. There have been approximately 15 trips per day. The top five towns were New Haven, Hamden, West Haven, North Haven, and Branford. The DOT has received two electric vehicles. There will be 22 gas vehicles arriving soon.

6. <u>Presentation: A Shared Vision To Reduce The Incarceration Rate While Making Communities Safer And</u> Stronger

Charles Grady from the FBI and Dr. Lorenzo Boyd from University of New Haven gave a presentation on re-entry from prison into the workplace.

7. COG Business

a. FY 2023-24 Budget Revision #6 (motion)

Chair Cofrancesco made a motion to approve the Revision at the Board level and waive the lack of an Executive Committee approval and all were in favor. Executive Director Amento advised there is \$25,000 being added to the budget for the CTDOT Active Transportation Microgrant Program. Motion made by Mayor Garrett and seconded by First Selectman Hoey. The motion passed unanimously.

b. Resolution Authorizing the Executive Director to extend an agreement with Brian Miller for FY 2023-24 Regional Services Grant-funded Consultant Services

Chair Cofrancesco made a motion to waive the lack of Executive Committee Executive approval and all were in favor. Mayor Garrett made a motion to table this item this item. The motion was seconded by First Selectman Lyons. The motion passed unanimously.

c. Executive Director's Report

Executive Director Amento advised that SCRCOG currently has 6 active employees and 4 vacancies. Amento also referred to the Newsletter on Cyber Security, Solid Waste and Recycling and an upcoming meeting hosted by the Grants Consultants.

d. Regional Planning Staff Report

Stephanie Camp, Senior Regional Planner, reported that meetings are being held with all municipal planners.

e. Regional Planning Commission April Action Table

Chair Cofrancesco referred to the attached Action Table.

f. Sustainable CT Update

Deputy Director Francis reported SCRCOG has received approval to have Fellow Jackie Flaherty assigned to SCRCOG to work with all municipalities on the Sustainable CT applications. The start date will be announced within the next week.

g. REX Development Report

Barbara Malmberg noted that REX had provided a spreadsheet of new businesses that have opened along with a new businesses guide. These will be provided to all municipalities, town halls, libraries and hotels in the next week.

h. Congressional Reports

Ellen Graham reported that the applications for Congressionally Directed Spending Program had closed on the U.S. Senate side as of April 14th. Lou Mangini reported that such funding requests for the House side will not close until late in FY 25. There is a possibility that non-profits will not be able to apply for the House spending program this year. Lou also suggested municipalities think of other municipal-driven projects that they will need funding for.

i. State Legislative Reports - CCM, COST

Brian O'Connor reported on several of the bills in a distributed CCM report including House Bill 5347 – School Construction, Senate Bill 452-- Board of Assessment Appeals, House Bill 5335-- Middle Housing, and Senate Bill 293-- Solid Waste,

j. <u>DEMHS Report</u>

Nicole Velardi reported that the Emergency Management Symposium was successful. The Migrant Response Planning workshop has been canceled due to low registration. For any town that participates in the Emergency Management Performance Grid (EMPG Grant), the 2020 reimbursements are due to DEMHS by May 31st. Towns are also able to apply for EMPG funding for EOC upgrades or Emergency Shelter upgrades. However, you cannot apply for both. Applications are due May 15th. The Homeland Security Grant Program memoranda need to be signed and returned to DEMHS by June 30th. The U.S. Preparedness Grants are open for applications due to DEMHS by June 3rd. The REPT By-laws update process is continuing. The next REPT meeting will be held on May 17th in Bethany.

8. Regional Cooperation/Other Business

First Selectman Freda advised that in surrounding communities you may see Be Kind signs. Ken Engleman may reach out to see if you would like these signs.

9. Adjournment

First Selectman Hoey made a motion to adjourn. First Selectman Freda seconded. The meeting was adjourned at 12:03 pm.

Whereas: The State of Connecticut has received annual Federal Section 5310 funding for

transportation of seniors and individuals with disabilities, since 1975; and

Whereas: The Bipartisan Infrastructure Law, reauthorizes surface transportation programs

for Fiscal Year (FY) 2022 through FY 2026; and

Whereas: Funding is apportioned based on Urbanized Areas (UZAs). The New Haven UZA

includes the South Central Region and portions of the Lower Connecticut River Valley Council of Governments (RiverCOG) to allow funds for capital and

operating expenses; and

Whereas; \$755,601 has been appropriated to the New Haven UZA for FY23, of which a

minimum of 55% must be used for capital purchases; and

Whereas: SCRCOG and RiverCOG, have reviewed all applications from interested non-

profit organizations, and prioritized projects based on criteria provided by

CTDOT; and

Whereas: Agreement has been reached among the above mentioned parties on the priorities

for capital purchases and operating funds after review of applications from

Drawing upon data from the State of CT's spring 2023 flyover, which will not be processed until June 2024, UVM will create a Regional Tree Study of the SCRCOG Region. The current study will be comparable to the 2018 SCRCOG Regional Tree Mapping Study also developed by UVM. SCRCOG will coordinate with the Yale School of the Environment (YSE,) sharing our Tree Mapping Study as we did with our 2018 Regional Tree Study with YSE, and, in turn, YSE will share their NASA-funded Heat Island Study of the region. Both studies will assist municipal and regional planners with determining where the planting of shade trees and other measures could be taken to mitigate extreme heat and its deleterious effect on human health.

5e. MS4 Mapping	
Consultant: To Be Selected	\$25,000

The proposed Regional MS4 Inventory seeks to take a geographic inventory of all MS4 assets within the SCRCOG region and develop a comprehensive database of locations, conditions, and characteristics of MS4 infrastructure. The purpose of the database will be to create an authoritative and standardized inventory of all MS4 assets in the region to allow for better prioritization of improvements, maintenance, and coordination between municipalities for stormwater resilience.

Details of Municipal Services Consultants (#6 above)

6a. Municipal Grants AssistanceMunicipal Grants Consultants: Juliet Burdelski/Renata Bertotti (continuing) \$60,000

SCRCOG will continue providing grants assistance to its member municipalities by offering: (1) grants training and workshops with the Regional Grants Working Group; and (2) research and information to member municipalities of relevant municipal grants opportunities; and (3) providing individualized grants writing and administration assistance to SCRCOG member municipalities.

6b. Solid Waste & Recycling, Food Waste Diversion and Composting Consultant: Pam Roach (continuing) \$70,000

SCRCOG will continue offering guest speakers, presentations, workshops, and discussions for its Regional Solid Waste & Recycling Working Groups. SCRCOG will also assist its member municipalities in the facilitation/promotion of resident education/communication through community-wide education programs and trainings, as well as the production of educational materials. SCRCOG will also provide individualized assistance to member municipalities in researching grant opportunities and assisting in applying for such grants. Finally, SCRCOG will provide assistance in municipal efforts to individually and collaboratively pursue new programs of glass and plastics recycling, and food waste diversion, as well as the conversion of existing municipal leaf and brush piles to use as composting facilities with the addition of food waste diversion.

6c. Information Technology/ Cybersecurity Consultant: Novus Insight (continuing) \$30,000

SCRCOG will continue offering cyberawareness training for SCRCOG municipal members' employees. Currently, 2010 municipal employees are involved in the training. The emphasis for the coming year and beyond will be on implementation of the OPM \$2.2 million Regional Performance Incentive Program (RPIP) grant funding for Regional Cybersecurity Assessment and Protection.

6d. Economic Development

Consultant: REX Development (continuing) \$90,000

In collaboration with the South Central Regional Council of Governments, REX Development will offer free on-call economic development services under SCRCOG's Municipal Services Program. These services will provide peer-to-peer coaching or direct service based on the market and organizational needs of the community. Such services will include:

On-Call Staff Coverage: when municipal staff is absent due to attrition or your staff is temporarily away or unavailable, the program will provide limited in-house coverage; Economic Development Training; Economic Development Consulting; Workforce Development; Resources; and Peer Review of Documents and assistance with the Local Economic Development Processes.

6e. Regional Energy Initiative

Consultant: People's Action for Clean Energy (PACE)

The SCRCOG consultant and staff will share resources and best practices with municipal Energy Task Forces to develop programs and take advantage of existing programs that will result in municipal energy efficiency savings and reduction of greenhouse gas emissions.

Below are highlights of the Proposed FY 2024-25 SCRCOG Budget.

Total Budget Increases by about \$942,500

The proposed FY 2024-25 budget totals \$8,412,550 as compared to a FY 2023-24 budget of \$7,470,044

Municipal Dues

The proposed budget includes a one cent dues increase. This increase will allow SCRCOG to provide match for and utilize federal transportation funding without creating unsustainably large carryovers of unused funds.

Office of Policy and Management - Regional Services Grant (RSG)

It is expected that RSG funding will remain stable at \$948,502. RSG funds, municipal dues, and competitively awarded grants received by SCRCOG, account for all non-federal revenue to SCRCOG. RSG funds are used for non-transportation regional planning, municipal shared services, and special projects.

Transportation Planning – Federal Funds and State Match

FY 2024-25 is the second year of the two-year Unified Planning Work Program (UPWP). CTDOT is providing its 10% match for both current-year funds and carryover funds.

Operating Expenses Increasing by about \$156,000

Total operating expenses¹ are increasing from \$1,650,583 this year to a proposed \$1,806,217 in FY 2024-25. The proposed budget includes a 2.6% general wage increase for all positions except the Director of Regional Planning (recently filled) and the Highway Safety Specialist position (salary determined by grant from CTDOT)². The remaining increases are largely due to the increased office rent³, computer equipment maintenance⁴, software subscription costs⁵, and legal fees⁶.

The content has not changed significantly since our last presentation in April. If you have any questions or comments regarding the CEDS update, please feel free to let us know.

As the tourism season approaches, Greater New Haven prepares for an influx of visitors. During the April REDFO meeting, Rachel Lenda, the Director of Tourism for the state, presented an ambitious vision for the upcoming season, emphasizing the importance of collaboration and innovation. Additionally, REX and the Town of Branford are taking the lead in hosting the state's listening tour, inviting all tourism-related businesses to share their insights and needs to ensure that state strategies align with community interests. Visit New Haven is actively engaging in the Central Regional Tourism District's brochure swap on May 20th, facilitating the dissemination of information to eager travelers. The arrival of the first of several groups from Lakeland, Florida (next week)—thanks to Avelo's latest destination—marks the beginning of potential partnerships in tourism and economic development. With these events and initiatives underway, Greater New Haven is well-positioned to showcase its diverse offerings and welcome visitors.

In collaboration with the City of New Haven, we recently participated in an exciting downtown tour for Ken Gosselin and Ed Stannard from the Hartford Courant.
