  - ➤ ESDHD Financial Advisor Updated Fund Recommendations Continued communication with Chris, continue to keep funds in the holding pattern, market still volatile, continue to monitor market and keep where funds are currently. Currently safe, secure and collecting interest. Continue to check in with him monthly.
  - ➤ Climate Change Photojournalism Project/Interns Status National Environmental Health Association (NEHA) Summer Internship Grant Proposal Status –Two currently working with ESDHD Yale and UCONN. Alberta student just joined the team. NEHA one to two students will potentially be joining team again in the fall. Meeting to be held to discuss project. Table planned at East Haven Fall Festival to share work with the community. Also, community conversations on climate change set up coming up in the library.
  - ➤ EPIC Clinical Database Contract is being reviewed by Yale's legal team. Once agreed an MOU will be signed. Process will take a few months, in addition to additional months to set up. Goal is Epic will be up and running by flu season (end September beginning October).

➤ Health Department file digitation project – Research has continued reviewing other health districts programs, including lessons learned. Staff meeting conducted to discuss next steps. This process will take several years to complete. All files will be scanned in house by a contracted company. All files need to be scrubbed first. The end goal is to improve customer service.

- Coronavirus Update / Vaccination Statistics/Clinics Local & State Update Presentation - Coronavirus Update / Vaccination Statistics – Local & State Update Presentation from the Director. He reviewed national statistics, statistical chart of Connecticut. Director reviewed all three towns in the district including, positivity rates, age distribution, fatalities, vaccination rates, trends. Discussion on effectiveness of Covid booster. A review of vaccines in children, there are a lot of hesitant per Dr. Young on parents to vaccinate their children.
