4. Old Business

- City of New Haven Opioid grant for \$386,000.00~ over four years received this past week. The opioid grant to fund a FT Harm Reduction Specialist.
- ESDHD Vacancies Status Starting salary \$60,000.00 for Harm Reduction Specialist. Have been interviewing. We have narrowed it down to a couple of candidates.
- Travel Clinic Program Dr. Young reports a steady rate of individuals attending the clinic.
- Yale CT DPH Fellowship Partnership/Summer Internships through workforce development grant (HHS, CDC), \$3,500.00 per semester per project Fellowship. ESDHD has 1 UCONN, 1 Yale, 1 Marist College, 1 Bridgeport University and 1 SCSU. One additional student we may fund. Potentially 6 students (one paid by ESDHD) for summer to work on several projects for the ESDHD. Director reviewed some of the upcoming projects for the summer.

5. New Business

- Epidemiology report Madison Wierzel recorded the report, played, and reviewed data, including hospitalizations and vaccination statistics.
 - Respiratory Reporting Diseases reviewed data and hospitalization rates.
 The season is winding down. This is the last month for reportable data.
 - Vaccination rates by town
 - Vector-borne disease recap.
 - Historical radon data
 - Current/Pending Grants New Grant Funded Position Status

Pending grants

- New Haven Green Fund \$8,000 for the possible opening of a shellfish bed in East Haven. Meeting pending with Aquaculture. Plans to test waters up the Farm River. Students will be helping with the Yale students.
- The first payment from the State Immunization grant was over a year ago. Slightly over \$200,000.00~.
- Funded for the pump out boat for repairs needed, CT DEEP will be funding, additional \$20,000.00~.
- MCH Grant will be increased to about \$485,000.00~ per year. This program is 100% funded.
- Workforce Development will be spending about \$60,000 this year (was 4-year grant).
- Academic Detailing grant outreach to reduce prescription opioids. Meeting with prescribing physicians. Dr. Young explained the education program.

Opioid discussion:

- Higher than average prescribing in our district. We are reviewing this matter and it may be associated with a high senior population, hospice, etc.
- By-Laws—Michael Pascucilla proposed to form a committee (the Bylaws are from 1974). Michael Director is currently working with legal counsel and reviewed potential updates.

6. Director's Report

- PHAB Accreditation Application Status met with them yesterday, documents submitted. They reported they are backlogged and they may not be able to review documents until November 2024.
- Budget Update Draft submitted to all three towns, met with North Branford and East Haven. Continues to move forward and most have supported. Increases proposed was 4% to yield \$13.41 per capita.
- ESDHD PH Activity Reports (Environmental, Emerg. Preparedness, Education & Nursing).
- ESDHD Personnel Discussion Executive Session Darlene Zimmerman made a motion to go into executive session, Susan Addiss' 2nd motion. Elaine Anderson made a motion to returned from executive session at 7:30 pm. Darlene Zimmerman 2nd motion. All in favor.
