Mr. Marrero updated the Board members on the Triennial Review process and progress. The Compliance Officer continues to conduct internal departmental audits and the Districts Certification and Assurances were submitted to FTA in February. The agency is currently working on the RFP for the Regional Rides program.

Mr. Marrero informed the Board members of the conversations with the attorney and Teamsters 443 President in preparation for the upcoming collective bargaining agreement negotiations.

GNHTD continues to work on new initiatives. The agency installed a Q' Straint One wheelchair securement system on a bus for trial.

GNHTD staff continues to attend seminars, workshops, and conferences. Mr. Marrero shared with the Board members the ongoing recruitment efforts of the agency. The agency hired a total of 5 drivers during the months of January and March. The agency also hired 3 dispatchers and is currently seeking a Mechanic and a Maintenance Coordinator.
