BE IT RESOLVED, that Joseph Carfora, as Mayor of The Town of East Haven is authorized and directed to execute and to deliver any and all documents on behalf of the Town of East Haven to enter into a services agreement with Motorola or its designee for purpose outlined herein.

Chairman Deko recognized Police Chief Edward Lennon who explained that during the budget hearings he addressed the multi-year deal with Motorola to continue/extend the current warranties at \$151,000 per year. It addresses the digital system with automatic upgrades.

Chairman Deko asked if it covers the radios. Chief Lennon stated that it covers the infrastructure.

Councilwoman Parlato asked if at any time could we get out of this agreement.

Chief Lennon indicated that there are only 3 vendors and Motorola is the best and covers all issues until 2026.

Finance Director, James Keeley stated that this is a complete agreement at a reduced cost and recommends it to the Council.
