


Greater Bridgeport Regional Recycling Interlocal Committee Meeting (GBRRIC)

- I. Call to Order
The Meeting was called to order at 10:02 am by Chairwoman Jennifer Tooker.
- II. To Review and Approve the Minutes of December 02, 2021
Mr. Estrada, moved to approve the minutes of December 2, 2021. Motion was seconded by Mr. Nowacki and APPROVED unanimously.
- III. Oak Ridge
 - a. Update on Separate Glass Pilot Program
Mr. Ratkiewich discussed the Glass Pilot Program, with tonnage reports from Fairfield, Westport, and Woodbridge. Southbury stated their interest in participating in the Separate Glass Pilot Program.
 - b. To Receive Update on Status of Operations for FY 2022
Mr. Sardone gave a status of operations for the Oak Ridge, Shelton location. Including single stream contamination, especially plastic bags.
 - c. Projected ACR Outlook
Mr. Decker and Mr. Sardone stated that the ACR should remain flat, as orders remain strong due to the opening up of domestic markets.
