Vice Chairman Pacelli recognized Police Chief Lennon and Asst. Chief Patrick Tracey. Chief Lennon explained the reasons for some of the overtime are one officer on medical leave, the cost of state mandated training continues to rise, and we are working in the director to be proactive.

Chief Lennon stated there are 121 standards to be completed by 2027.
