East Haven Town Council Minutes

The East Haven Town Council held its Regularly Scheduled Meeting Tuesday, July 5, 2022, at 7:30 p.m. or immediately following certain public hearings at the East Haven Community Center, 91 Taylor Avenue, East Haven, CT in order to transact the following:

Chairman Deko called the meeting to order at 7:01 p.m.

Pledge of Allegiance and a moment of silence for what is going on in our country.

Chairman Deko moved item #14.

Councilwoman Lesco read the following, to consider and act upon a resolution that Joseph Carfora, as Mayor of The Town of East Haven or his designee, is authorized and directed to execute and to deliver any and all documents on behalf of the Town of East Haven to enter into a contract with *Axon Enterprise*, *Inc.* for public safety equipment, including body worn cameras, video equipment and less lethal equipment.

Chief Lennon and Deputy Chief Tracey addressed the council. Chief Tracey explained that Axon Enterprise Inc. is on the state bid list for body and car camera, Tasers, video storage, and photo maintenance. The Police Department needs accountability and it is now mandated for Animal Control, Fire Marshal, Building Official, and Zoning/Blight Official. With those additional departments it made more sense to create one account. We renegotiated and took advantage of our current contract with 2022 prices. There was an unanticipated cost due to the cost regarding microchips. The equipment is fully warrantied for repairs and replacement and we are guaranteed equipment upgrades. The tasers will be replaced with a safer model and the body cameras will live stream, automatic notification for license plates and assists in solving crimes. In closing, Chief Lennon stated that the State of Connecticut is the only state to require both body and car cameras.

Chairman Deko indicated that this contract is good for 10 years and will increase the line item for FY 22/23 as necessary.

Chief Tracey stated that this new contract will void the current contract.

Councilwoman Martin stated that there will be no increase for 10 years.

Councilwoman Cesare clarified the effective date will now be August 1, 2022. She also asked if any of the equipment could be traded in for credit and if any is still usable.

Councilwoman Parlato asked if there was any penalty associated with increasing the contract for 10 years.

Councilman Vollono noted that surrounding towns are short officers, are we experiencing the same.

Chief Lennon indicated that we recently only received 8 applicants.

Attorney Luzzi did indicate that we are all working closely with Civil Service to get qualified and quality candidates.

Councilwoman Cesare moved to approve. Councilwoman Martin second the motion. Voice vote-All in favor. None opposed. No abstentions. Approved
