BE IT FURTHER RESOLVED that this resolution shall be construed as to limit the discretion of the commission to schedule additional meetings, as necessary, to accomplish its goals.

Chairman Carbo read the dates out for the public to hear. A member of the public asked why there was a meeting scheduled on December 23, 2015 which was so close to the holiday. Chairman Carbo stated at these meetings, there will be no public comment; these meetings are being held for transparency and informational purposes. Chairman Carbo went on to state he would answer this one question concerning the December 23, 2015 meeting date. Chairman Carbo stated the Subcommittee has to hold to a very tight meeting schedule and must use every available date, even if it is near a holiday.

Chairman Carbo asked for a motion to approve a Resolution setting the Regular Meeting Schedule of the 200 Tyler Street Subcommittee.

## Ms. Asid made a motion to approve a resolution setting the Regular Meeting Schedule of the 200 Tyler Street Subcommittee, Mr. Lang seconded the motion. Voice Vote: All in favor, none opposed, no abstentions, motion carried.

## Item \#7:

General discussion of subcommittee priorities, assignments, and steps for keeping the public informed as to the progress of the subcommittee.

Chairman Carbo stated all meetings will be held in the public eye, and will hold public hearings. Vice-Chairman Limoncelli asked if there were any tasks which could be assigned, Chairman Carbo responded not at this meeting, but by the next meeting assignments will be given out.

Town Attorney Joseph Zullo stated in order to help facilitate the subcommittee, he would ask Sal Brancati, East Haven Economic Development Coordinator, to get packets together containing all research gathered for the 3 alternative uses for the building; education, municipal conversion, private developer.

Chairman Carbo stated this subcommittee would not be making the final decision; it is only here to make a recommendation to the East Haven Board of Finance and the East Haven Town Council.

Town Attorney Zullo stated the East Haven Zoning Dept. to get the addresses of homes which abut 200 Tyler Street so as to facilitate sending out meeting information to those residents.

Chairman Carbo asked Mr. Brancati if the property could be used for education since the East Haven Board of Education turned the building over to the Town of East Haven. Mr. Brancati responded the Town does indeed own the building and the Town would have to ask the Board of Education if they felt the need for the building. Mr. Brancati stated he would contact the Board of Education.

Vice-Chairman Limoncelli stated on the general meeting topics sheet, it states the January 12, 2016 and January 20, 2016 are to be public hearing meetings. ViceChairman Limoncelli went on to ask the clerk of the subcommittee to publish when the public hearings will be held.

Ms. Asid asked Mr. Brancati if the packet will include monies available for each of the 3 alternatives, Mr. Brancati stated it will.

Chairman Carbo asked the subcommittee members if there were any other comments, concerns, or questions, there were none.

Chairman Carbo asked for a motion to adjourn the meeting.
Vice-Chairman Limoncelli made a motion to adjourn the meeting, Ms. Asid seconded the motion.
