Assistant Chief's Report: January 30, 2023

- I. Personnel
  - **a.** Firefighter Chris Hughes successfully passed his check ride with a Doctor and was granted medical authorization as a Paramedic by YNHH-CEMS
  - **b.** Captain Robert Black and Captain Michael Cieplak attended the CT. Career Fire Chiefs Assoc. 6 day, iLead course at the CT. Fire Academy. Both feel they learned a great deal and gained as Officers.

# II. Training

- a. Training and buildout of the First Due record management system is on-going. Battalion Chiefs and Captains received training on the scheduling and response portions of the software a few weeks ago and DC Murray is currently training the rest of the career personnel. Once completed we will begin user testing the scheduling software to work out any issues prior to moving over to it completely from Aladtec (current scheduling software).
- b. DC Murray has created an In-Station Training Calendar for both the Career and Volunteer members that will supplement the specialty and mandatory training topics that he delivers throughout the year. The lesson plan follows the IFSTA Firefighter 1 training course with added review of Department operations, guidelines, and procedures. There are 43 lessons and each lesson will be completed over a 2-week period.
- c. Annual department live fire training is being scheduled for early March.
- **d.** The Department will be conducting a Firefighter 1 course for volunteers who wish to become certified. Classes will be held on 1 weeknight and a few hours on Saturdays each week. The course will begin and March and run for 3 months.

- **b.** Emergency eyewash equipment was installed on the sinks on the apparatus floors at Fire HQ, Station3, and Station 4.

- **b.** DC Murray will distribute firefighting gear to volunteer members who will participate in the Firefighter 1 Course.
