For health insurance the library's total cost for 14/15 was \$131,307 total employee contributions for health insurance was \$10,467 for 7 employees. Making the total cost for health insurance \$120,902. The library was allocated \$117,389 by the town so there was a \$3,500 deficit and that is where the deficit arose. This year's costs are in line with the towns' allocation. I think it may be best for the library to make a presentation to the BOF in the future on how the library is handling the health insurance. It would help if you would provide your expectations and or questions you would like answered in advance to me. It

would help structure the presentation to meet expectations. There were a combination of factors that caused a shortage there was a misalignment of actual working hours, regular salaries, there was a pay raise to retain an employee, staff vacations and staff meetings. A good degree of this has been resolved in this year's budget in covering staff expenses. Staff expenses due to leave is being reviewed now. I look forward to tentative dates Mr. Rizza so we can speak about health insurance if there are questions or expectations.
