## EAST HAVEN FIRE COMMISSION MEETING July 27, 2020

Conditions of employment were outlined by Chief Marcarelli and made part of Vice Chair Verderame's motion. The motion was seconded by Commissioner Leonardi. There was no discussion. A roll call was taken – Commissioners Coyle, DeLucia, Leonardi, and Verderame voted yes and the motion carried.

A motion was made by Vice Chair Verderame to make a conditional offer of employment for the position of Certified Firefighter Grade D Lateral to candidate Eric Demeraski. Conditions of employment were outlined by Chief Marcarelli and made part of Vice Chair Verderame's motion. The motion was seconded by Commissioner Leonardi. A roll call was taken – Commissioners Coyle, DeLucia, Leonardi, and Verderame voted yes and the motion carried.
