EAST HAVEN TOWN COUNCIL REGULAR MEETING MINUTES TUESDAY, DECEMBER 1, 2015

The East Haven Town Council held a regular meeting Tuesday, December 1, 2015, at 7:00 PM (immediately following the scheduled public hearing) at the East Haven Community Center, 91 Taylor Avenue, East Haven, CT 06512

Acting Chairman Robert Sand called meeting to order at 7:31 PM.

Item #1

Roll Call – 13 Council Members present, 2 Council Members absent (Chairman Fred Parlato and Councilman Gary DePalma) A quorum was present.

Acting Chairman Sand asked all to stand for Pledge of Allegiance. Acting Chairman Sand then asked for a moment of silence due to the death of a Town resident who has been involved in and worked for the Town.

Item #2

Approval of minutes from the November 16, 2015 Special Meeting.

Acting Chairman Sand asked the Town Council if all had read the minutes, if there were any questions, concerns, corrections. Acting Chairman Sand then asked for a motion to accept the minutes from the November 16, 2015 Special Meeting.

Councilman McKay made a motion to accept the minutes from the November 16, 2015 Special Meeting, Councilman Anania seconded the motion. Roll call was taken, all in favor, none opposed, no abstentions, motion carried.

Item #3

Approval of minutes from the November 16, 2015 Public Hearing Meeting.

Acting Chairman Sand asked the Town Council if all had read the minutes, if there were any questions, concerns, corrections. Acting Chairman Sand then asked for a motion to accept the minutes from the November 16, 2015 Public Hearing Meeting.

Councilman Butler III made a motion to accept the minutes from the November 16, 2015 Public Hearing Meeting, Councilman McKay seconded the motion. Roll call was taken, all in favor, none opposed, no abstentions, motion carried.

Item #4

Correspondence.

Acting Chairman Sand asked acting recording clerk, Stacy Gravino, if there was any correspondence, there was none. Acting Chairman Sand stated he did not have any correspondence per se, only to congratulate the East Haven High School Varsity Football Coach Melvin Wearing being named State Coach of the Year for his outstanding work with the team.

Item #5

Subcommittee Reports.

Acting Chairman Sand stated not all of the assignments had been made to the various subcommittees as of yet, Chairman Parlato was working on it. Acting Chairman Sand stated there were a few assignments made.

Acting Chairman Sand stated Councilman Parente would stay on the Board of Education Subcommittee, Councilman Santino would stay on the Public Safety Subcommittee, Councilman Richardson was assigned to the Finance Subcommittee, and Councilwoman Esposito would stay on the Parks and Recreation Subcommittee. Councilwoman Esposito refused the assignment, stating she would prefer another subcommittee. Councilwoman Archambault stated she would like to be assigned to the Parks and Recreation Subcommittee.

Acting Chairman Sand stated with the formation of the 200 Tyler Street Blue Ribbon Commission, Councilman McKay would be assigned as the liaison between the Town Council and the Commission for the duration of the Commission's existence. Councilman Palladino stated some of the public had questions concerning the appointment of some of the individuals to the 200 Tyler Street Blue Ribbon Commission, and, he would like to have a motion made to include one Town Council Member from each of the 5 districts be appointed to the Commission. Councilman Palladino stated if the Commission had elected Town Council representation, it would squelch the negativity.

Acting Chairman Sand stated at this time, the Town Council was not looking to overload the Commission, the Town Council just wanted to have one person come back to the Town Council with information. Acting Chairman Sand stated Councilman Palladino is welcome to broach the subject again when Chairman Parlato returns to his duties. Councilman Butler III stated since he was no longer needed on the Finance Subcommittee, he would go on any other Subcommittee.

Acting Chairman Sand asked for public comment. Dan McCann, 137 Mansfield Grove Road, East Haven, stated the Independent Party won 1% in the 2015 Municipal Election, and wanted to know if the Independent Party would be given a seat at the table. Town Attorney Joseph Zullo stated since no one representing the Independent Party was a current member of the Town Council; they would not be given a seat at the table. WHEREAS, The Town of East Haven (hereafter, "Licensor) is the owner of the public road known as "Crisci Place," located in East Haven, Connecticut; and

AND, WHEREAS, the Dominick and Lynn Crisci (hereafter, "Licensee") are the owners of property at the end of Crisci Place known as "19 Crisci Place"

AND, WHEREAS, the Licensee wishes to construct a fence to be located on the Licensor's property to prevent the illegal dumping of rubbish and other materials by third parties on the property known as 33-35 Pardee Place Extension, said fence to be located at the end of Crisci Place;

AND, WHEREAS, the parties wish to memorialize their agreement in a written "License Agreement" relative to the construction of said fence;

AND, WHEREAS, on November 4, 2015, the East Haven Planning and Zoning Commission issued a favorable 8-24 referral regarding the proposed License Agreement;

NOW, THEREFORE, BE IT RESOLVED that said License Agreement is hereby approved and Mayor Joseph Maturo, Jr., or his Designee, is authorized to execute the same and all necessary, related documents.

This resolution shall be effective in accordance with the provisions of the East Haven Town Charter.

Acting Chairman Sand asked for a motion to open up Item #10 for discussion.

Councilman Santino made a motion to open up Item #10 for discussion,

Councilman McKay seconded the motion. Roll call was taken, all in favor, none opposed, no abstentions, motion carried.

Acting Chairman Sand asked for comment from the public, there was none. Acting Chairman Sand asked for comment from the Town Council.

Town Attorney stated the owners of 19 Crisci Place will be erecting a fence to improve their quality of life because of illegal dumping of trash. Property owners will pay for, maintain, and insure fencing. The property owners received a positive 8-24 referral from the Planning and Zoning Commission to erect the fence because the fence would sit on the right of way which the Town of East Haven owns. The Town Engineer went out and stated everything was in order. Councilman Santino had a problem with this because it is a dead end street, and during snow storms public works piles snow in this area. He wanted to know if Town will have to pay for damages. Town Attorney Zullo indicated it was his understanding that the Town will only pay damages if it was the plow itself which damaged property, not the snow. Councilman Santino also stated driveways are near this fence, will there be issues with the snow and people's driveways. Councilman Sand asked if neighbors were notified of the fence, Attorney Zullo told him as part of the Planning and Zoning Commission's decision, the neighbors were informed and invited to an informational meeting. Councilman Anania questioned why the owners of 33-35 Pardee Place weren't putting up the fence because it appeared to be on their property. Attorney Zullo stated the fence would be on the right of way which runs along the back of 33-35 Pardee Place. End of Town Council comment.

Roll call was taken, all in favor, none opposed, no abstentions, motion carried.

Item #11

A Resolution amending the Standing Rules of the Legislative Town Council.

A Resolution amending the Standing Rules of the Legislative Town Council

WHEREAS, the Town Council Standing Rules provide that said rules may be revised or amended by resolution to be considered at a regular meeting of the Town Council;

AND WHEREAS, the Town Council Chairperson has deemed it necessary and prudent to revise said rules to provide for a transparent, efficient process for soliciting resumes and making appointments subject to the appointing authority of the Town Council;

NOW THEREFORE, BE IT RESOLVED that the following "Section I" shall be added to the Town Council Standing Rules following "Section H:"

"SECTION I - PROCEDURE REGARDING TOWN COUNCIL APPOINTMENTS

Unless otherwise provided by State Statute, Town Charter, or local ordinance, all appointments to boards and commissions for which the Town Council is the appointing authority shall be vetted through the following application process:

- In December of each calendar year, the Council Chairperson shall compile a list of "open" or "vacant" appointments for which the Town Council is the appointing authority.
- 2. At any time prior to, but in no case later than, January 10th of the following calendar year, the Council Chairperson shall publish a notice in a paper having at least a weekly circulation in the Town of East Haven announcing the Council's acceptance of resumes from prospective applicants for open/vacant appointments.
- 3. The notice provided for in Section 2 shall require applicants to submit resumes to the attention of the Town Council Administrative Services Committee, which shall serve as the review and vetting subcommittee for all applications.
- 4. At the Administrative Services Committee meeting in advance of the first Town Council meeting to be held after February 1st of each calendar year, the members of the Administrative Services Committee shall review all resumes submitted by prospective applicants for open or vacant positions.
- 5. Members of said committee, after reviewing all of the applicants for each open or vacant appointment, shall vote upon a recommendation to be made to the full Town Council with respect to each appointment. The recommendation of the Administrative Services Committee, along with the resume of the recommended

- appointment, shall be forwarded to the Town Council and placed on the next Town Council agenda for consideration by the full Town Council.
- 6. If the applicant recommended by the Administrative Services Committee is not confirmed or approved by the Town Council, the Council Chairperson shall request an alternate recommendation from the Administrative Services Committee for consideration at the next Town Council meeting. This process shall repeat until the vacancy or open position is filled.
- 7. Nothing in this section shall be interpreted to limit or abrogate the appointment powers of the Town Council as provided by State Statute, Town Charter, or local ordinance or to limit the rights, if any, of Council members to raises motions, in the proper procedural fashions, to make appointments to boards and commissions in any other fashion."

This resolution shall be effective in accordance with the Standing Rules and in accordance with the provisions of the East Haven Town Charter.

Acting Chairman Sand asked for a motion to open Item #11 up for discussion.

Councilman Santino made a motion to open item #11 up for discussion,

Councilwoman Hennessey seconded the motion. Roll call was taken, all in favor, none opposed, no abstentions, motion carried.

Acting Chairman Sand asked for comment from the public, there was none. Acting Chairman Sand asked for comment from the Town Council. Town Attorney Zullo explained this amendment only concerns the appointments to Town Boards and Commissions which the Town Council approves, not any of the Mayoral appointments.

Councilwoman Lettieri-Morales asked how does a Town Council Member get on the Adminstrative Council. Attorney Zullo stated it is at the sole discretion of the Town Council Chairman.

Councilman McKay asked about vacancies, stated if someone resigns, what is the procedure for fill the vacancy. Councilman McKay asked if the procedure would be the

same. Attorney Zullo stated vacancies were not taken into consideration at the time, but now realized vacancies should have been; the procedure would be the same.

Councilman Palladino stated for the record it was he who had been asking for this amendment for two years from the Town Attorney, at the disagreement of current Chairman Parlato. Councilman Palladino very adamantly let the public and the Town Council knows he took offense to the language of the amendment because Chairman Parlato never pushed for this amendment; it was Councilman Palladino who had been pushing for it.

Acting Chairman Sand asked for a motion to approve a Resolution amending the Standing Rules of the Legislative Town Council with the addition of the wording concerning vacancies.

Councilman Santino made a motion to approve a Resolution amending the Standing Rules of the Legislative Town Council with the addition of the wording concerning vacancies; Councilman Butler III seconded the motion. Roll call was taken, all in favor, none opposed, no abstentions, motion carried.

Item #12

Short training session regarding the use and deployment of Chromebooks.

Town Attorney Zullo gave out Chromebooks to all of the Town Council Members. He instructed them on how to use devices, that they would be receiving Town email addresses which would be listed on Town website. Attorney Zullo also told the Town Council these devices are FOlable, so use your discretion as to what you load onto them. Council was informed all future agendas, minutes, packets would be sent via email, no longer will any be supplied on paper.
