Re: East Haven Town Hall – Limited Access- *through Monday, December 7, 2020* due to COVID-19 19- Essential Services available.

Due to confirmed positive cases of COVID-19 in a limited, non-public area of the East Haven Town Hall, the need for individuals impacted by these results to quarantine, and the increasing risks of COVID-19 19 infections, Town Hall will be closed to the public <u>through</u> <u>Monday, December 7, 2020</u>, with limited exceptions for essential services by appointment only.

All contact tracing and proper evaluations have been conducted by the East Shore Health District. Those who require quarantine have been so informed, and are adhering to proper protocols.

The administration along with East Shore Health District continues to monitor and evaluate the situation in our community, and the surroundings area. Additional information regarding the status of Town Hall will be provided no later than 2:30 PM, Thursday, December 3, 2020.

While we continue to work hard to limit any disruption to public services, we do request the public's co-operation by only requesting in-person appointments when absolutely necessary, and conducting routine business with the Town via email, on-line through the <u>website</u>, through the mail, or by telephone.
