TO ASSUME ALL RISK AND RESPONSIBILITY for any injuries or other damage I may sustain and any damages I may cause in Pasquale DiLungo Veteran's Memorial Rink and The Town of East Haven, its employees, vendors, agents, designees, assigns, successors, and/or heirs, guests, invitees or lessees or any other person in connection with my reason for being on the premise under control of THE RELEASES (including anything in connection with equipment rented from the above mentioned entities or their affiliates:

TO RELEASE THE RELEASEES, from ALL CLAIMS OF LIABILITY for any injuries which I may sustain or any damage that may be caused to me or my property in connection with my activities at the Pasquale DiLungo Veteran's Memorial Rink, (including, without limitation, injuries that may be caused from equipment I may rent even if my injuries are caused in whole or in part by the negligence or fault of THE RELEASEES, their employees or instructors):
- 3. I WILL NOT SUE OR BRING LEGAL ACTION AGAINST the above named RELEASES, their affiliates or their respective administrators, employees, or instructors and owners or lessors of the property:

- 5. I authorize THE RELEASEES, to use photographs, videotape, or any other record of the events which may depict me, at their discretion, without compensation paid to me:
- 6. EACH SKATER (ROLLER OR ICE) SHALL:
 - A. Maintain responsible control of his speed and course at all times:
 - B. Heed all posted signs and warnings:
 - C. Maintain a proper outlook to avoid other roller/ice skaters and objects:
 - D. Accept the responsibility for knowing the range of his own ability to negotiate the intended direction of travel while on roller skates and to skate within the limits of that ability: and
 - E. Not be distracted by use of electronic devices or any other devices:
 - F. Refrain from acting in a manner which may cause or contribute to the injury of himself or any other person: and I agree to obey said rules and regulations of all State Laws. I fully understand that roller/ice skating is a very dangerous sport and recreational activity, I acknowledge and fully understand that each skater and participant will be engaging in activities that may involve the risk of serious injuries) including temporary or permanent), death and social and economic losses which might result from the RELEASEES action, in action's or negligence, but also actions, in actions' or negligence of others, the conditions of the premises or any equipment use and/or rental. Further, there may be other risks not known to the RELEASEES and myself not reasonably foreseeable at this time that will likewise be included in this release:
- 7. I understand that if I feel there is insufficient supervision or that the RELEASEES are not complying with its duties and responsibilities posted, I shall cease my activity and advise the RELEASEE of the condition:
- 8. Should any provision of the Release be held invalid or unenforceable by any court of competent Jurisdiction, all other provisions shall continue in full effect:

I acknowledge that there have been no representations made to me by the RELEASEES and I AGREE TO HOLD THE RELEASEE HARMLESS for any injury or loss that I may cause to any other individual or the premise. I FURTHER AGREE TO INDEMNIFY the above set forth RELEASEES in the event of any such injury or loss for which they may be held responsible:
