## EAST HAVEN TOWN COUNCIL SPECIAL MEETING MINUTES TUESDAY, DECEMBER 5, 2017

The East Haven Town Council held a special meeting Tuesday, December 5, 2017, at 7:00PM at the East Haven Senior Center, 91 Taylor Avenue, East Haven, CT 06512.

Mayor Joseph Maturo Jr. calls the meeting to order at 7:13PM.

Item #1

Roll Call-13 present- 2 absent (Parlato and Butler III). A quorum is present.

Mayor Maturo asks all to stand for the pledge of allegiance and a moment of silence for the passing of Councilman Anania's mother—in-law and Councilman Parente's cousin and anyone else who has passed since the last meeting.

#### Item #2

Appointment of a temporary Clerk of the Legislative Town Council.

Councilman Richard Anania makes a motion to nominate Danelle Feeley. Councilman Nicholas Palladino seconds the motion. Voice vote: all in favor-none oppose-none abstain. Motion carries.

Councilman Robert Parente calls for a Republican caucus. Councilman Joseph Santino calls for a Democratic caucus. Republican and Democratic caucuses begin at 7:14PM.

Mayor Maturo calls the meeting back to order at 7:20PM.

#### Item #3

Election of a permanent Chairperson of the Legislative Town Council.

Councilman Parente nominates Ken Mckay.

Councilwoman Judy Esposito seconds the nomination.

Councilman Joseph Badamo nominates Nicholas Palladino Councilman Louis Pacelli seconds the nomination.

Councilman Santino nominates Steve Tracey.

Councilman Tracey declines the nomination.

Councilman Paul Carbo made a motion to close nominations.

Councilman Anania seconds the motion.

Voice vote: all in favor-none oppose-none abstain. Motion carries.

#### Roll call vote:

7 in favor of Ken Mckay (Parente, Mckay, Esposito, Hennessey, Tracey, Carbo and Anania).

6 in favor of Nicholas Palladino (Santino, Deko, Palladino, Pacelli, Carfora and Badamo).

Motion carries with Ken Mckay as Chairman.

Mayor Maturo thanks everyone for their service on the Council; he indicates no matter what party affiliation they have his door is always open. He introduces Joseph Coppola to the Council who has taken over the position in his office for Frank Gentilesco who has retired. He thanks Frank Gentilesco for all of his work over the past 16 years.

#### Item #4

Election of a permanent Vice-Chairperson of the Legislative Town Council.

Councilman Tracey nominates Linda Hennessey.

Councilman Parente seconds the nomination.

Councilman Carfora nominates Louis Pacelli.

Councilman Palladino seconds the nomination.

Councilman Parente makes a motion to close nominations.

Councilman Santino seconds the motion.

Voice vote: all in favor-none oppose-none abstain. Motion carries.

#### Roll call vote:

7 in favor of Linda Hennessey (Parente, Mckay, Esposito, Hennessey, Tracey, Carbo and Anania).

6 in favor of Louis Pacelli (Santino, Deko, Palladino, Pacelli, Carfora and Badamo). Motion carries with Linda Hennessey as Vice Chairwoman.

#### Item #5

Appointment of a permanent Clerk of the Legislative Town Council.

Councilman Anania nominates Danelle Feeley. Councilman Santino seconds the nomination.

There were no other nominations.

Roll call vote: all in favor-none oppose-none abstain. Motion carries.

#### Item #6

General review of Council Standing Rules, procedure, and relevant Freedom of Information provisions.

Town Attorney Joseph Zullo addresses the Council and indicates he will be giving the Council an updated conflict of interest letter to disclose that the Council Clerk is his fiancé. He explains that the Council member's powers come from the Town Charter. If there is any question as to what they are authorized/capable to do or what is allowable, their rights, responsibilities and duties are in the Town Charter. The second place to look to how the Council operates is the Standing Rules. They have pushed that every board/commission have standing rules and most do and the Council's are lengthy and clear in delineating how the Council meets and how public comment is regulated. He explains that all comment is to go through the Chairman; the Chairman can relax this especially during budget time when it is a casual process and he can enforce it at any time. Council members generally raise their hand to speak and are recognized by the Chair, if they are not recognized they should probably not be speaking. Second, there are standing committees which the Chair will appoint members to, he has the option to do it tonight but he may forego it and wait a month as it was undetermined who would be there and how the results would end up. Third, the biggest thing is the State's Freedom of Information Act; they are all a public body and everything they do that would involve the public's interest the public has the right to know about and can hold them accountable for. He encourages them to use their official Council emails, which have been set up for the new members as well; three members are without tablets but they will have them once they are transitioned from the past members. If they conduct official business on their personal email, it is official business and subject to FOI; if they issue text messages during the meeting to another Council member or member of the

public, there is a ruling out there from FOI and arguably it is public business so he cautions them all to be careful about what they say, civil in what they say and to conduct business in public. Finally, they can only conduct business when they are assembled as this body, they can all do their own investigation as a lot of members spend time in Town Hall finding out the facts and issues before they come to the meeting but they cannot assemble a quorum of people outside of this room to conduct business, strategize or discuss items on the agenda. Chance meetings and social gatherings are okay but he cautions them about the blurry areas.

- Councilman Palladino says there is a clear misunderstanding of the standing rules with regard to cancellation of meetings. It is not strictly at the discretion of the Chairman to cancel for any old reason; there are specific reasons and it can't just be because he wants to. There are only certain reasons to cancel meetings, not because he [Attorney Zullo] is on vacation, the public knows when these meetings are being held and they have a right to be there unless there is a snowstorm, flood or other serious emergency. The previous Chairman thought it was at his discretion and it is not.
- Attorney Zullo says the standing rules provide the reasons for cancellation of a
  meeting and one of them is "other reasonable cause" and the prior Chairman had
  his understanding of what reasonable cause constitutes and Chairman Mckay
  may have another understanding. They drafted the schedule of meetings and
  tried to be cognoscente of every possible thing that could come up. He is sure
  the Chairman will do the best he can to honor the schedule.
- Councilman Palladino says it's other reasonable causes, not because he felt like it. That's why there is a Vice Chair and there are other Attorneys besides him if he is on vacation.
- Attorney Zullo says there is an entire profession of people that debate what reasonable cause constitutes but he understands his concern. He adds he wanted to mention something in regards to public comment, especially to Councilman Pacelli who came from the Board of Education where public comment was as of right and could be on any topic at the beginning of the meeting. Public comment is by item on the Town Council, it does not apply to procedural matters or scheduling matters it only pertains to matters of substantive items. Someone from the public can't just come up and comment on any item, it has to be something on the Agenda and when the person is commenting it must be pertinent to the item on the Agenda and if it is not, the Chairman has the right to gavel the person off.
- Councilman Carbo asks if the item has passed already, can someone bring it back up for public comment.
- Attorney Zullo says no.

- Councilman Badamo says they could make a motion to bring it back.
- Attorney Zullo says the Council can always make a motion to add something to the Agenda at a Regular Meeting by a 2/3 vote so if someone has perhaps missed their public comment opportunity it is in the Chairman's discretion to add it. If it passed already, it is a moot point.
- Councilman Badamo says if someone comes in late for the public session, would they be able to speak.
- Attorney Zulio says generally speaking no but it will be at the Chairman's discretion. That is also why there are often multiple opportunities to speak on items either during the Public Hearing and then again when the item comes up as an Ordinance.
- Councilman Badamo says there were times when he was on the Council in the
  past where someone came up and wanted to speak and they were told they
  missed it and it is too late. They are there representing the people of the Town so
  they should let them speak their piece.
- Chairman Mckay says if someone comes in and wants to speak on an Ordinance they already passed, it really is a moot point at that point but they will play it by ear.

He will take everyone into consideration and then come up with the subcommittees for the next meeting. He asks that they table the item until the next meeting.

Councilman Palladino makes a motion to table Item #7.

Councilman Pacelli seconds the motion.

Voice vote: all in favor-none oppose-none abstain. Motion carries.

# AUTHORIZING ORDINANCE OF THE East Haven Town Council

An Ordinance Abandoning the Town's Interest in a Portion of Rose Street (AKA Rose Street Extension)

**WHEREAS**, the owner of 4 Center Street has requested that the Town of East Haven abandon its interest in the following:

1. The unimproved portion of Rose Street (AKA Rose Street Ext.) from its intersection on the south with the northern boundary of West Street to its intersection on the north with the southern boundary of Center Street.

**AND WHEREAS**, the proposed abandonment of said road has been investigated by the Planning and Zoning Commission, which has issued a favorable referral regarding the same pursuant to C.G.S. §8-24;

**NOW, THEREFORE BE IT ORDAINED** that the unimproved portion of Rose Street (AKA Rose Street Ext.) from its intersection on the south with the northern boundary of West Street to its intersection on the north with the southern boundary of Center Street is hereby abandoned as a public roadway;

**BE IT FURTHER ORDAINED** that the abandonment of the foregoing roads is hereby made subject to the retention by the Town of East Haven of any sewer, water, or utility easements as may exist in or over said property.

This Ordinance shall be effective in accordance with the provisions of the East Haven Town Charter.

- Finance Director Paul Rizza says basically the "To" account is from the Counseling Department. He explains that 4 or 5 years ago they started to outsource the employees; rather than being Town employees they were from BH Care and there was an increase due to one of the BH Care employees replacing a Town retiree. The "from" account has \$18,000 coming from regular salaries because that is what was left after the Town employee retired so they are moving it to the contractual account. The other areas are accounts with surplus monies after the year-end closed. They are evening out the plus's and minus's.
