The East Haven Town Council held the Regular Meeting on Tuesday, January 3, 2012, at 7:30 p.m., at i the East Haven Senior Center, 91 Taylor Avenue, East Haven, Connecticut 06512

Town Council Chairman Richard Anania called the Town Council Meeting to order at 7:30 PM.

Chairman Anania asks everyone to stand for the Pledge of Allegiance.

1. Roll Call.

Zullo wanted to advise the Town Council that he was appointed as an assistant town of attorney for the Town of East Haven primarily for zoning and land use matters. Attorney Alfred J. Zullo also wanted to disclose the potential conflicts to his employment by the Town as required by the Town Charter.

Paul Rizza addressed the Town Council to advise that the transfer of \$30,000 for water is to cover the cost of water use for town buildings, fields and the splash pad. Mr. Rizza advised that before the splash pad was installed there was expenditure for water use of \$16,000. In fiscal year 2010/2011 the total expenditure was \$42,000. Budget from 2011 was approved to \$20,000. The splash pad in total used \$14,000 of this budget.

Mr. Rizza opened the floor to the Town Council to ask questions:

Councilwoman Beverly Gravino asked if the splash pad had its own meter. Mr. Rizza replied yes.

Councilman Fred Parlato asked if the fire hydrant water use was a separate charge. Mr. Rizza replied yes. Councilman Parlato also inquired as to if there was an additional cost for the WPCA during the summer time. Paul Rizza advised that there is a charge for water coming in and water coming out. Councilman Joseph Santino Jr. advised that there are 2 separate meters and that the only charge for the WPCA is for the bathrooms during summer use.

Councilman Michael Riolino asked if there were any other accounts to transfer the money from before using the contingency account. In the past the money has been able to be transferred from different accounts. Mr. Rizza stated that all department heads were currently in review of their accounts. There is currently only \$800 left in the water account.

Councilman Fred Parlato asked if there was a 2010-2011 audit filed as of date and when will it be available to review. Mr. Rizza stated the audit was filed with the state and that it would be available for distribution in the next couple of days.

Councilman Robert Sand asked what the balance of the contingency fund will be after the \$30,000 transfer. Mr. Rizza advised it would be \$390,000.

Councilman Anthony Mansi stated that the water bill should be taken care of now as so we do not incur any interest.

Chairman Anania calls for public comment. Public Comment made by:

Adam Mansi (76 Hobson Street) asked for clarification of the amounts spent last year and in prior years. Mr. Rizza confirmed that \$42000 was this year, \$16000 2 years ago, \$31000 last year.

Donna Riccio (67 Charnes Drive) Outstanding water bill is how much? Mr. Rizza stated balance is approximately \$6.000. Ms. Riccio asked if the additional \$24,000 was an estimation of future bills. Mr. Rizza replied yes.

Thomas Thompson (21 Mill Hill Circle) encouraged a no vote until further analysis is done. Mr. Thompson stated that when he brought transfers to the Town Council he had a financial report for each transaction.

Chairman Anania asked for a roll call vote. 5 No-(Gary DePalma, Beverly Gravino, Joseph Santino Jr., Joseph Badamo, Michael Riolino) 10 Yes-(Robert Parente, Fred Parlato, Anthony Purificato, Judy Esposito, William Richardson, Robert Sand, Robert Cubellotti, Richard Anania, Paul Carbo, Anthony Mansi) Motion Carried
