# EAST HAVEN TOWN COUNCIL REGULAR MEETING MINUTES TUESDAY, MARCH 3, 2015

The East Haven Town Council held a regular meeting Tuesday, March 3, 2015, at 7:00PM at the East Haven Senior Center, 91 Taylor Avenue, East Haven, CT 06512.

Chairman Richard Anania calls the meeting to order at He asks all to stand for the pledge of allegiance.

#### Item #1

Roll Call-12 present-3 absent (Santino, Esposito and Badamo). A quorum is present.

#### Item #4

## Correspondence-

 Letter from Angelo Santomassimo of 11 Mallard Lane to Chairman Anania on February 17, 2015. Mr. Santomassimo writes that he feels the mailbox policy put in place this January is unfair. During the snowstorm the first week of February his mailbox was hit by a plow and damaged. Mr. Longley of public works told him that he hit the mailbox. He followed the guidelines of the policy he received from Town Hall and received a letter from the Town Attorney who said it was being reviewed, two days later a second letter from the Town Attorney which said they found it was damaged by the weight of the snow being thrown by the plow therefore his claim was denied. He asked if he could be put on the docket and come to the next Council meeting to speak during public session and he was then told the Council had nothing to do with it, the policy was put in place by the Town Attorney so he could not come before the Council to speak. He feels he is being shut out because of who he is.

- Chairman Anania states for the record that the mailbox policy is not new; it was just revised by the Legal Department. It is really nothing to do with the Council; we don't handle any kind of legal claims.
- Councilman Nicholas Palladino says he doesn't know the average cost of a new mailbox, but what does it cost us to have our Legal Department review the claims, are these all billable hours or is this part of what we pay? Is it costing us \$500 to say we are not going to replace a \$25 mailbox?
- Town Attorney Joseph Zullo says no, it costs nothing; it is all part of the general retainer.

## Subcommittee Reports-

- Public Service- Councilman Sand says he did not attend the Commissioner's
  meeting so he doesn't have anything specific other than the promotions we
  recently saw in the paper and he asks if the Deputy Chief can elaborate on
  anything else he has. As far as public service, Bob Parente would be able to
  update on the status of the equipment.
  - Deputy Police Chief Ed Lennon says they had the promotions of one Sargent to Lieutenant, one Officer to Sargent and we have since hired two Certified Officers who we did not have to pay to have trained. One is currently on field training and one starts April 1<sup>st</sup>.
  - Councilman Fred Parlato says he noticed there are 4 Police cruisers covered with snow in the parking lot, are they out of service?
  - Deputy Chief Lennon says he doesn't believe all of them are; they are mostly used for traffic duty. One of them he knows is out of service.
  - o Councilman Palladino asks if we lost an Officer due to a training situation.
  - Deputy Chief Lennon says that is a personnel matter he doesn't believe he should discuss in public.

- Board of Education- Vice Chairman Robert Parente says the Board of Ed finalized their budget for the upcoming year and they are well on their way for the reorganization of the school system.
- Parks and Rec- no report.
- Urban Renewal- there is an agenda item tonight set a public hearing for the Small Cities Grant.
- Board of Finance- Chairman Anania says they are starting their budget workshops tonight.

## No public comment.

Council comment:

- Councilwoman Gravino asks what software we have that this can be processed with no question. Shouldn't it be a red flag that this isn't ours?
- Town Attorney Joseph Zullo says it is a matter of logistics because if any time in and around the time of October 1<sup>st</sup> when the grand list is set, the vehicle isn't utilized/registered/located in East Haven, we set the grand list as if it is part of the grant list because we don't know otherwise. By the time the paperwork catches up it may be a week to a month by the time the plates get turned in. That's why it is common to see vehicles taxed in the wrong Town. The only other time you see that is with business equipment, which we have had in the past, where it was unclear because of how close the business was to another Town and where it was being kept. In most cases it is a matter of logistics.
- Councilman Butler III says it happens a lot with leases, which are registered out of State.
- Attorney Zullo says that's another instance when you turn a lease in, by the time the leasing company notifies the Tow and turns in the plates, it takes that much longer.

- Councilman Mckay asks what town it was supposed to be taxed in?
- Attorney Zullo says he can ask Lisa to include that from now on.
- Councilwoman Gravino says every Department head who has something on the agenda appears before the Council, we see the Town Engineer, Fire Chief, Paul Rizza, etc. but Lisa doesn't come and she doesn't know the reason why. There are times when Mr. Rizza or Attorney Zullo doesn't have the complete answer because they haven't had the opportunity to look into it. Is there a reason the Tax Collector doesn't come when she has something on the agenda.
- Attorney Zullo says his only thought is two of the Department heads you won't see often are Mike Milici and Lisa Basilicato. They are Union employees where the Engineer, the Town Clerk, PD and FD Chiefs, etc. aren't union. It can be a grey area to ask someone to come in after hours. Lisa does come to the Finance meetings when a transfer is requested. If the Council would like her to come, he suggests speaking to Frank Gentilesco Jr. to make sure there aren't any labor issues.
- Councilman Mckay says a lot of the questions have been answered in the last few years, it used to be much more vague. She has been good with the paperwork he just would like it to be added what Town it should go to.
- Chairman Anania says he did receive an email that she was unable to come tonight she had something at her daughter's school.

Roll call vote: all in favor-none oppose-none abstain. Motion carries.

#### Council comment:

- Councilman Butler III says he brought this up another time when they talked about an issue with a double payment. Was there a possibility for a penalty for double payment? For having to do all the paperwork and giving them back the money.
- Attorney Zullo says it is rare that you get people who overpay usually the problem is underpayment. He says he doesn't know about an administration fee for a refund. We suffer no measurable harm; it doesn't cost the Town anything for his services or the Council or Lisa who is already being paid. If there is any detriment it is small, it's more of an inconvenience. In this case it is one of those real estate transactions where the closing Attorney paid it not knowing the client already has. We can look into it he doesn't know if it is a policy the Town wants to take. He doesn't make the policy he just advises of the legality of it. He would have to look into whether it is legal and then it is up to the Council as well as the Mayor's Office.
- Councilman Butler III says even if it is a \$25 fee that they have to pay back, if it is legal.

#### Council comment:

- Councilman Palladino says he is going to ask the same question he asks every time we do this. The Town Charter says we appoint these people yet he doesn't know these people he knows nothing about them and is being asked to appoint them. How can he say that this person should be on this board that the Town Council is appointing when they see nothing on them; no resume, what they do for a living or even that they live in Town. Can we eventually come up with a resolution, like other Towns have because he did research, so we have something for when someone wants to be on a Board that the Council appoints they present something to us. It should not just be names that are given to us by Town Hall, no matter who the Mayor is. The prerequisite shouldn't be that the Mayor gave this name; the Mayor has their appointments to do however he/she wants, ours should be done the way other Towns do it by presenting a resume, coming before the Board and asking to be on the commission.
- Chairman Anania says the names did not come from Town Hall. People came to him about the openings. Steve Delucia called him and he submitted a resume which he does not have with him but he does electrical contracting work with a company that does school buildings and things to that nature.

- Councilman Palladino says that may be a conflict of interest if he contracts with the Town.
- Chairman Anania says he does not have a contract with the Town of East Haven; he works for a contractor that does these types of repairs. Jan Cianelli for the Americans with Disabilities Commissions, she has a handicap grandson and was very interested in that and they need people on that board.
- Attorney Zullo says if a Councilperson would like to draft a resolution he would be happy to review it. The Council is the policy maker and they are always welcome to submit Ordinances or resolutions for consideration at Administrative Services to be presented to the Council. It's part of the job actually.
- Councilman Butler III says he does think we should look into something with this
  because the last person we appointed for ADA never showed up after we voted
  on them. Maybe we should just have a letter or something saying they would like
  to be on a board because of whatever reason so we have something to look at.
- Councilman Palladino says there are 15 members of the Council, the Chairman received a resume but nobody else saw it. Nothing against him personally but if he has it, why doesn't everyone else have it? The Chairman isn't being asked to vote on it exclusively, they all are. He will put something together to present so we don't have this problem again.
- Councilman Mckay asks if Administrative Services is the place to bring that up, to which Chairman Anania says yes it is.
- Councilman Mansi asks if a lot of people applied.
- Chairman Anania says that was it, some of the positions we get a few people but these were the only names.

- Town Clerk Stacy Gravino says yes, this is year 5 of a multi-year grant. This year they received less money from the State; the number of deeds each Town takes in drives it. Because there is less purchasing of homes, we had less money so it decreased from \$7,500 last year to \$4,000. This means she kicks in a little more from her \$1 fund without asking the Town for any money.
- Councilman Sand says he asked Stacy if there was a light at the end of the tunnel and she said there was.
- Ms. Gravino says it is in 1970, she is now at 1954.
