APPLICANT & PROPERTY OWNER: Julius Delguidice; Property Affected; 234 Dodge Avenue : Map 180, Block 2110, Lot 01; Zone R-1

*Proposal to build new house (single family).*

APPLICANT & PROPERTY OWNER: Carlos & Suannette Galarza; Property Affected; 130 Florence St; Map 420, Block 5223, Lot 002; Zone R-2

*Proposal to construct a new deck on side of the house, deck will be 10 ft by 12 ft.*

**VARIANCE: Schedule 'B' Line #7, Reduction of 5 feet to 20 off the street line, where 25 feet is required.**

Susannette Galarza addressed the Board on her behalf. She was seeking a variance reduction of 5 ft. to 20 ft. off the street line, where 25 ft. is required to construct a new deck 10 ft. by 12 ft. The required certified receipts were submitted. Attorney Zullo read into record the hardship: positioning of the house on lot does not allow for the area required and the front steps are deteriorating. No further comments were made

APPLICANT & PROPERTY OWNER: Martin Hallier; Property Affected; 104 Frontage Road; Map 260, Block 3210, Lot 001; Zone CC

*Proposal to develop gas station, convenience store and retail store.*

**VARIANCE: Schedule 'B' Line 7, street line reduction from 25 feet to 0 ft, for proposed canopy and 25 ft to 9 feet for proposed pump island. NOTE: Street line is highway line of Route 1 which steps back further than adjacent parcels.**

APPLICANT & PROPERTY OWNER: Theresa Campbell: Property Affected: 164 North Atwater Street; Map 070, Block 0717, Lot 017, Zone R1

*Proposal to extend existing front deck to the end of the front of house & wrap around the existing side deck.*

***VARIANCE: Schedule 'B' Line #9 side yard setback 3 ft where 10 feet is required and Schedule 'B' Line #7; 17 feet where 25 is required, 8 foot reduction for street line setback.***

Michael Campbell addressed the Board on behalf of the applicant. He was seeking a variance to extend the existing front deck to the end of the front of the house and wrap around the existing side deck. The required certified receipts were submitted. Attorney Zullo noted to applicant no hardship was noted on his application and if he agreed to this stated hardship: property preexists zoning, small lot, house positioned too close to street line, application would be granted with condition that applicant would have to file hardship on record as stated in ZBA office. Applicant agreed. No further comments were made.
